## WHAT IS APOGEE?

Apogee is a 501(c)3 nonprofit organization with a special SSO (Student Scholarship Organization) Georgia designation, which allows Apogee to provide its contributors with not only a Federal charitable contribution, but also a dollar-for-dollar GA tax credit.

## WHAT DOES THIS MEAN?

Georgia taxpayers can direct their state tax dollars to Frederica Academy as opposed to the state Department of Revenue.

## EVERYONE IS A WINNER!

**DONOR:** Earns a voice in how their tax dollars are being used for education. A dollar-for-dollar tax credit on state tax return for the donation amount and the possibility of also using donation as a charitable deduction on federal return.

Married Couple Filing Jointly	\$2,500
S-Corp	\$10,000
Member of an LLC	\$10,000
Partner in a Partnership	\$10,000
C-Corp or Trust	Up to 75% of GA Tax Liability

3. File your GA State taxes for 2020 and deduct a tax credit for the full amount of the payment made in March 2020 (around April 2021).
