HOW TO ENROLL?

Individual Filor

- 1. Visit https://www.apogeebase.com/donate to enroll online prior to the beginning of December 2019.
 - a. Please designate Frederica Academy as your recipient school, and enroll based on your tax filing status:

- 2. Make your payment to Apogee by March of 2020.
- 3. File your GA State taxes for 2020 and deduct a tax credit for the full amount of the payment made in March 2020 (around April 2021).

WHAT IS APOGEE?

Apogee is a 501(c)3 nonprofit organization with a special SSO (Student Scholarship Organization) Georgia designation, which allows Apogee to provide its contributors with a dollar-for-dollar Georgia tax credit.

WHAT DOES THIS MEAN?

Georgia taxpayers can direct their state tax dollars to Frederica Academy as opposed to the state Department of Revenue.

EVERYONE IS A WINNER!

DONOR: Earns a voice in how their tax dollars are being used for education. A dollar-for-dollar tax credit on state tax return for the donation amount and the possibility of also using donation as a charitable deduction on federal return.
